How to Participate in the JV Program.

International Companies

The JV program is driven by international companies of any size who are looking for a Pennsylvania partner. An international company should reach out to <u>Pennsylvania's Authorized Investment Representative</u> in their home market to begin the conversation. If there is no representative in your country, please contact <u>Alex Mederos</u> at BusinessPA.

After that conversation, opportunities are anonymized and presented on the <u>JV program website</u>. Currently, there are three categories of opportunities: manufacturing, food processing, and technology.

Pennsylvania Companies

The JV program can only be successful if Pennsylvania companies find interesting opportunities through it. Pennsylvania companies, economic development organizations, and local governments are invited to review the opportunities listed on the JV program website to see if any might be of interest to their company, or a company in their community.

Once a Pennsylvania company has identified an opportunity that is of interest, the company should <u>email Alex Mederos</u> at BusinessPA with the JV reference number and some background on their company, its capabilities, and its interests in the JV opportunity. BusinessPA will then pass the background information to the international company. If the international company believes the Pennsylvania company would be a good match, BusinessPA will facilitate an introductory conversation.
